The public meeting was structured as an Open House. Community members were invited to walk through the displays, ask questions of the project team, and to provide comments.

Key: Questions (Q), Answers from the Project Team or County of Maui (A), Comments (C).

- **C:** Interest in the process for obtaining and planting plants to mitigate erosion in front of the Nā Kai 'Ewalu Canoe Hale.
- **C:** Hawaiian Canoe Club (HCC) lease of the western part of the site is being finalized. HCC is seeking grants to restore or upgrade the traditional hale. Behind the traditional hale, HCC is hoping to continue usage of this area for canoe storage, and to create a canoe plant garden.
- **C:** There are 'iwi in the park. There is a known burial with a State Historic Preservation Division marker adjacent to HCC hale.
- **C:** One sand source Sand was brought in on a ship from Canada 10,000 tons comes through the port twice a year. Manufactured sand by the CSL Company.

Online Open House, October 30 – November 30, 2024.

The community meeting materials were hosted online on the project website after the public meeting. The website functionality enabled community members to submit comments directly to the project team. The meeting information was shared via a press release from Maui County before the October 30th meeting, and again during the Open House period to solicit comments. The members of the Project Advisory Committee were also encouraged to share the website with their communities.

Website use

The project team used Google Analytics to track website use during the online open house. During the open house period, the open house site received 373 page views from 184 total active users. The website received the most traffic immediately after the release of the online open house with a slight increase in traffic between November 15-18 when the second press release was released.
